School events should provide a healthy, safe and enjoyable atmosphere for all students. The following behavior expectations are designed to ensure positive dance environments for our students, staff and community.

FCPS/Linganore High School Expectations and Consequences for Students and Guests:

- > Entry to the dance will be denied for inappropriately revealing, sexually suggestive or disruptive dress.
- The dance is only for the students of the home school and their guests.
 - o All attendees must be enrolled in grade 9 or above, all guest must be under 21 years of age.
 - o All **guests** must complete the FCPS High School Dance Guideline and Guest form.
 - o must return later than 2:30 pm on 5/3/24 to Ms. Davies (C214) or Ms. Cassidy (C200)
- Everyone is expected to behave in a respectful manner, consistent with the policies and procedures of FCPS. This includes:
 - o I will adhere to the guidelines while on the dance floor.
 - o I will dance appropriately, appropriateness is defined by the administration, to include, but not limited to:
 - o Avoiding sexually suggestive/explicit dancing includes: suggestive squatting, bending, freaking, grinding, touching of the breasts, buttocks, or genitals or simulating sexual activity.
- I understand that the use of drugs/alcohol is illegal and that the use of either is an infraction of both Frederick County Public Schools policy and Maryland law.
- Once participants enter the dance, they are not permitted to leave and return.

FCPS/Linganore High School Consequences for Students and Guest

- > Students violating these guidelines will be removed from the dance.
- Parent/Guardian will be called.
- Any infraction against FCPS policy and Maryland law will potentially result in school consequences and/or criminal prosecution.
